Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the action of the Respondents herein particularly Respondent No.3 in not registering the sale deed in favour of the Petitioner on the sale certificate being issued by the Respondent No.4, dated 14.12.2021 under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest (SARFAESI) Act, 2002 despite the Respondent No. 4 issuing the certificate by enclosing the copies of the judgments rendered by the Honorable Apex court and also by the Honorable Supreme Court of India not to have any objection and also with regard to the registration is concerned as nothing but illegal, arbitrary, erroneous, high handed and violative of Articles 21 & 300 A of The Constitution of India and consequently direct the Respondent No. 3 to register the sale deed submitted by the petitioner on the execution made by the Respondent No. 4 basing on the sale certificate, dated 14.12.2021issued under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002;

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondent No.3 to register the sale deed submitted by the petitioner on the execution made by the Respondent No. 4 basing on the sale certificate dated 14.12.2021 issued under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest (SARFAESI) Act, 2002, pending disposal of the Writ Petition No. 946 of 2022, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of SRI.A.K.KISHORE REDDY Advocate for the Petitioner and of learned GP for Registration & Stamps, for the Respondents, the Court made the following.

## **ORDER:**

Challenging the inaction of the 3<sup>rd</sup> respondent in registering the sale deed in favour of the petitioner on the sale certificate being issued by the 4<sup>th</sup> respondent, dated 14.12.2021, under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest (SARFAESI) Act, 2002, despite the 4<sup>th</sup> respondent issuing the certificate by enclosing the copies of the judgments rendered by the Hon'ble Apex Court, the present Writ Petition is filed.

This Court is of the opinion that the Registrar can only reject the document by passing appropriate order under Section 71 of the Registration Act, 1908. The petitioner is, therefore, directed to present his document in accordance with law. The Registrar, is thereafter, directed to decide the correctness of the document presented and if for any reason he is of the opinion that it cannot be registered, he has to pass necessary order under Section 71 of the Act.
