		1. Learned Assistant Government	
		Pleader, appearing on behalf of the	
		respondent No.3, placed before this Court a	
		copy of the letter dated 26.07.2021. On	
		perusal of the said letter, It is apparent that	
		the beneficiary namely the National	
		Highways authority of India, which is	
		implementing project of formation of	
		national highways including road and rail-	
		over bridge has indicated that on account of	
		re-alignment, certain extents of lands, which	
		were previously notified, are not required	
		and that the required lands lie in Nagapatla	
		Village.	
		2. Paragraph Nos.4 to 6 of the letter	
		reads as under:	
		"4. During the site inspection by the Regional Officer, NHAI, Vijayawada on 27.09.2020, it was proposed to change the alignment from Km 88+300 (i.e. near Nagapatla Village)to the endpoint at Km 97+280 of old alignment (i.e. S.V. Zoo Park). As per the revised proposal the alignment will deviate from Km 88+300 and passes through Ramireddipalle, Nagapatla, Mittapalem and Kallur cross villages and merges with end pint of NH-205 near Kallur village (Km95-707 as per la alignment). 5. It is to submit that in view of the change of alignment, the area under Pudipatla, Cherlopalli and Mittapalem villages and some area under Nagapatla village which were previously notified	

are now not falling in the new alignment. Therefore, awards for Pudipatla, Cherlopalli and Mittapalem Villages are not required and requested to withdraw the same. As regards Nagapatla village, a fresh award may please be issued based on the new alignment (i.e. where the alignment changed to avoid forest lands and by merging the alignment in the existing road near KMM college by connecting the existing road to newly constructed R & B (NH) road & ROB).

- 6. In the light of the above, Joint Collector-II & CALA is requested to furnish the supplementary proceedings for the revised interest calculation on basic market value for both main and additional awards for the villages as mentioned in para-5 above per the revised alignment. It is further requested to furnish 3A particulars for the changed alignment as mentioned in para-4 above in the portion of Nagapatla, Mittapalem, Ramireddipalle & Kallur cross villages for taking necessary action in this regard."
- 3. The communication is not Pattadar specific or Survey number specific. It would be more appropriate if the respondents including the NHAI and 3rd respondent are able to furnish details to the Court as to the Survey number and the extent in each Survey number that is required for formation of the highway, etc., and the Survey numbers and extents which are not required for the purpose of the projects undertaken.
- 4. The details shall be placed before the Court by the next date of hearing.
- 5. List the matter on 18.04.2024.
- 6. It is made clear that liberty is granted to the respondents to also communicate this decision to the petitioners.
