Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction, more particularly one in the nature of writ of mandamus, to declare the action of the respondents interfere in Survey No.465-1 an extent of land AC.0.61 situated in Byravaram revenue village, Dutttaluru Mandalam, SPSR Nellore District and dispossess the petitioner there from without following due process of law is illegal, arbitrary and unjust and without jurisdiction or authority and in violation of Articles 14, 21 and 300A of the Constitution of India and in violation of principles of natural justice and consequently direct the respondents not to resort to the above said action without following due process of law.

And not to dispossess the petitioner there from, pending disposal of WP 890 of 2021, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of SRI BATHULA RAJ KIRAN Advocate for the Petitioner, and of GP FOR REVENUE for the Respondents, the Court made the following.

ORDER:

"Heard the learned counsel for the petitioner and the learned Assistant Government Pleader for Revenue.

The grievance of the petitioner in the present Writ Petition is that the respondents are trying to dispossess the petitioner from the land in question without following due process of law.

The learned counsel for the petitioner places reliance on the latest adangal dated 19.11.2020 and also pattadar pass books.

Considering the same, there shall be an interim direction to the respondent No's.1 to 5 not to dispossess the petitioner from the subject land without following due process of law.

The learned counsel for the petitioner is permitted to take out personal notice to the respondent No's.6 and 7 by registered post with acknowledgment due and file proof of service in the registry within a period of three(3) weeks.

List the matter after four(4) weeks."
