ORDER

The writ petition is filed to declare the proceedings dated 28.05.2015 in NO.P.Admn.A1/1588/2015 on the file of the 3rd respondent as illegal, unsustainable and violative of Arts. 14, 16 & 21 of Constitution of India apart from being violative of the provisions of Act 4 of 2014 dated 27.06.2014 and consequently direct the respondents to continue the petitioner in service till he attains the age of 60 years.

- 2. Since the matter pertains to the enhancement of age of the superannuation from 58 to 60 years, and in view of the fact that the petitioner could not succeed in obtaining any interim order in the present case, this Court feels that the cause in the writ petition does not survive.
- 3. Accordingly, the Writ Petition is dismissed as infructuous. There shall be no order as to costs.
