Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the inaction on the part of respondents 2 to 7 on petitioners Spandana Application dated 22.01.2024 submitted for construction of new cement pipes culvert to discharging water under the R and B cement concrete road near Punthala Musalamma Temple, so as to prevent entry of water to the houses of petitioners/villagers of Cheepurugudem Village in Nallajerla Mandal of East Godavari District, as illegal, irregular, irrational and amounts to non discharge of legal obligation under the provisions of Andhra Pradesh Panchayat Raj Act, 1994 and

offends Articles 14 and 21 of the Constitution of India and consequently direct the respondents to construct the new cement pipes culvert to discharging water under the R and B cement concrete road near Punthala Musalamma Temple.

IA NO: 1 OF 2024

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents not to lay further cement road, unless construct the New culvert near Punthala Musalamma Temple of Cheepurugudem Village in Nallajerla Mandal of East Godavari District, Pending disposal of WP 2150 of 2024, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri PATHURI SRINIVAS Advocate for the Petitioner and of GP FOR PANCHAYAT RAJ RURAL DEV for the Respondent Nos. 1 to 3, GP FOR ROADS AND BUILDINGS for Respondent Nos. 4 to 6, Sri N SRIHARI, Standing Counsel for Respondent No.7 and the Court made the following.

ORDER

"Heard Mr.Srinivas Paturi, learned counsel for the petitioners. Also heard learned Assistant Government Pleader representing the Panchayat Raj Department, learned Assistant Government Pleader representing the Roads & Buildings Department, learned Assistant Government Pleader representing the respondent No.2/District Collector, East Godavari District at Rajamahendravaram.

Learned counsel appearing on behalf of the respondent No.7/Cheepurugudem Gram Panchayat placed a copy of the written instructions dated 30.1.2024 received from the Panchayat Secretary, Cheepurugudem Gram Panchayat for perusal of this Court, wherein it is interalia stated that the construction of culvert was undertaken by the Roads & Buildings Department.

Be that as it may. As seen from the instructions dated 30.1.2024 received from the Executive Engineer (I/c), R&B, Kovvur/ respondent No.6, which are placed for perusal of this Court by the learned Assistant Government Pleader for Roads & Buildings Department, it would appear that there is a dispute between the Villagers with regard to construction of culvert. While one set of the Villagers state that there is a culvert in existence for the last hundred (100) years and unless a new culvert is constructed at Punthala Musalamma Temple, their houses would be affected whereas the other set of

Villagers are opposing construction on the ground that if the culvert is constructed, their houses would be affected.

Be that as it may. As the petitioners have made a complaint/representation through Spandana Programme, this Court is of the considered view that the matter requires intervention by the respondent No.2/District Collector for resolving the issue. Therefore, there shall be a direction to the respondent No.2 to take immediate action on the petitioners' complaint/representation dated 22.1.2024 within a period of two (2) weeks from the date of receipt of a copy of this order. Till such time, construction of cement road shall not be proceeded with.
