WHEREAS the Petitioners above named through their Advocate SRI G RAJU presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ more in the nature of Writ of Mandamus declaring the action on the part of Respondent No.2 Higher Education Council in issuing the Notification for exercising web-option for admission into B.Ed. Course for the academic year 2022-23 through EdCET-2022 on a very short notice, fixing the revised schedule for commencement of online process from 25.01.2023 to 27.01.2023 (only 3 days) thereby, depriving the Petitioner to exercise the web-option for the Bachelor of Education course and subjecting the Petitioner to great hardship and jeopardizing career as being arbitrary, illegal, unwarranted and violative of Articles 14 and 19 of the Constitution of India and violative of the provisions of Andhra Pradesh Universities Act and the Rules framed there under and consequently direct the Respondents 2 and 3 to extend the date of counselling from 25.01.2023 up to 31.01.2023 thereby enabling the Petitioner to exercise the web-option to participate in the counseling for EdCET-2022 for B.Ed. Course for the academic year 2022-23.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri G RAJU Advocate for the Petitioners, GP FOR HIGHER EDUCATION for the Respondent Nos. 1 to 4, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
