ORDER:

The instant Criminal Petition under Section 482 of the Code of Criminal Procedure, 1973 has been filed, by the Petitioners/Accused Nos.1 to 3, seeking to quash the proceedings against them in Crime No.18 of 2022 on the file of Chagalamarri Police Station, Kurnool District registered for the offence under Sections 447, 465, 468, 471, and 506 read with 34 of Indian Penal Code, 1860.
