### ORDER:

"Learned Standing Counsel Sri Josula Bhaskar appearing for the 1<sup>st</sup> respondent sought two (02) weeks time and opposed for grant of interim direction.

Learned senior counsel Sri Dammalapati Srinivas appearing for the petitioner submitted that as per the notice served, they will appear before the investigating agency and cooperate with the authorities.

In fact learned counsel for the petitioner has also brought notice of this Court that the *defacto complainant* as well as the petitioners have compromised the matter and it was ended in Lok Adalath.

Considering the submissions made by the learned counsel for the petitioner though it was opposed by the public prosecutor, there shall be a direction to the respondents not to take coercive steps against the petitioner herein. Further the petitioner is directed to cooperate with the investigating agency.
