Aggrieved by the action of the respondents in interfering with the petitioners possession and enjoyment of the agricultural land situated in Sy.No.364 of Jaggampeta Village and Mandal, East Godavari District, without following the due procedure under law, in order to allotment of the house site Pattas in favour of the beneficiaries under the Scheme "Navaratnalu – Pedalandariki Illu" launched by the Government of Andhra Pradesh, the instant writ petition is filed.

- Today when the matter is taken up for hearing, the learned Assistant 2. Government Pleader for Revenue has placed on record a copy of the written instructions received by him in the case, wherein it is stated by the respondent No.4 that the subject land in Sy.No.364 situated at Jaggampeta Village is not proposed for house site pattas. He further submits that the contention of the petitioner that respondents are interfering with his possession and enjoyment of the subject land would not merit consideration and thus prayed for dismissal of the writ petition.
 - The written instructions of the respondent No.4 dated 29.11.2024 is placed on record.
 - In view of the submissions made on behalf of the respondents the writ 4 petition is disposed of, as the grievance of the petitioner is resolved.
 - Accordingly, the Writ Petition is disposed of. There shall be no order as 5. to costs.

As a sequel, all pending miscellaneous applications shall stand closed.
