## ORDER:-

"Heard Sri B.Rama Krishna Naik, learned counsel for the petitioners, and perused the record.

This Court, by order, dated 22.10.2020, in I.A.No.1 of 2020 in W.P.No.15388 of 2020, granted interim direction to maintain status quo as on the date of the order for a period of four weeks and it was extended by this Court and the said order is in force as on today.

Learned counsel for the petitioners brought to the notice of this Court through the photographs filed at page Nos.24 and 25 along with the contempt case to demonstrate that in spite of the order of status quo, the respondents are proceeding with the construction activity.

On perusal of the material available on record, this Court prima facie satisfied that the order of this Court is violated by the respondents.

Therefore, Registry is directed to issue notice in Form-I to the respondents. Post on 16.4.2021."
