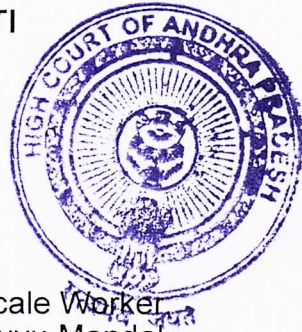

WHEREAS the Petitioner above named through their Advocate Sri C Raja Sekhar Reddy presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order of direction, preferably one in the nature of Writ of Mandamus and to declare the Impugned Proceedings Memo No.310/A/A3/2010, dated 06.07.2012 of the 1st respondent in rejecting the case of the petitioners for regularization their service in their respective category without any application of mind and also without going into the merits of the case is highly illegal, arbitrary, unreasonable, discriminatory and also in violation of Art. 14, 16 and 21 of the Constitution of India and set-aside the same and consequently direct the respondents to regularize the services of the petitioners in their respective category as per the records available and with all consequential benefits.
