In the meanwhile, there shall be interim stay subject to condition that the petitioner herein shall pay 25% of the arrears of maintenance amount within a period of eight (8) weeks from the date of receipt of a copy of this order and on further condition that he shall continue to pay the maintenance amount of Rs.20,000/- (Rupees Twenty Thousand only) per month to respondent Nos.1 to 3 herein, instead of Rs.30,000/-, on or before 10th day of every succeeding month. ”
