Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue any writ, order or directions particularly in the nature of WRIT OF MANDAMUS declaring the action of the 1st Respondent in absorbing the 4TH Respondent from Central Labour Service in to AP Government Service as Additional Commissioner of Labour as special case, by creating supernumerary post of Additional Commissioner of Labour, O/o the Commissioner of Labour vide G.O.Ms.No.4 dated 07.03.2024 as arbitrary, illegal and violative of principles of natural justice and under Articles 14, and

21of the Constitution of India and against the service rules and consequently to set aside the same.

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to suspend the G.O.Ms.No.4 dated 07.03.2024 issued by the 1st Respondent absorbing the 4th Respondent from Central Labour Service in to AP Govt Service as Additional Commissioner of Labour as special case, by creating one supernumerary post of Additional Commissioner of Labour, pending disposal of the Writ Petition No. 6445 of 2024, on the file of the High Court.

3. It is submitted by Sri O.Manohar Reddy, Learned Senior Counsel that the post of the Un-official Respondent No.4 is now hanging in the air. In the event that he joins in the Parent Department, this Court clarifies the position that such joining shall not cause prejudice to his rights in the present case and his right to be considered in the A.P.State Cadre and the same shall be subject to the final outcome in the present Writ Petition.
