Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or directions, more particularly one in the nature of Writ of Mandamus, declaring the illegal action of the respondents 4 and 5 and their men in interfering with construction, peaceful possession and enjoyment of house site Plot No. 140 in Sy.Nos. 299,298 and 296/3, an extent 40 x 33 Square Feets i.e., Ac.0.03 cents, situated at Panchalingala Village Fields, Panchalingala Grama Panchayat, Kurnool Rural Mandal, Kurnool District and rejected the petitioner application by Notice Rc.No. 15/PS/2021, dated. 20-08-2021, by the 5th respondent, without following the due procedure, which is illegal, arbitrary, unjust, violation of Articles 14 and 300-A of the Constitution of India and consequently set aside rejected Notice Rc.No. 15/PS/2021, dated. 20-08-2021, issued by the 5th respondent and further direct the respondents herein not to interfere with the construction and dispossess petitioner and his family members from the subject house site or otherwise petitioner and his family will suffer serious finance loss and great hardship.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to grant stay against the respondents in interfering with the construction and dispossessing petitioner and his family in respect of house site Plot No. 140 in Sy.Nos. 299,298 and 296/3, an extent 40 x 33 Square Feets i.e., Ac.0.03 cents, situated at Panchalingala Village Fields, Panchalingala Grama Panchayat, Kurnool Rural Mandal, Kurnool District, pending disposal of WP.No.9143 of 2022, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri Challa Sivasankar, Advocate for the Petitioner and GP for Revenue for Respondent Nos. 1

to 4 and Sri Vinod.K.Reddy, Standing Counsel for Respondent No.5, the Court made the following.

ORDER

"The learned counsel for the petitioner has submitted that in view of the patta granted on 20.08.2009, the petitioner has made an application to the Gram Panchayat for approval. But, the Gram Panchayat has issued notice on 30.08.2021 directing the petitioner to get the proof of originality and the respondents are not permitting the petitioner to proceed with the construction. Hence, the present Writ Petition.

Learned Government Pleader has submitted that patta granted in favour of the petitioner was not cancelled so far by the respondent authorities.

In view of the same, the respondents are directed not to dispossess the petitioner and not to interfere with the possession of the petitioner over the subject house site plots, without following due process of law
