## IN THE HIGH COURT OF ANDHRA PRADESH::AMARAVATI THE HON'BLE SRI JUSTICE B. KRISHNA MOHAN WRIT PETITION No.7677 of 2023

## **ORDER:**

Heard the learned counsel for the petitioner and the learned Assistant Government Pleader for Revenue for the respondents.

- 2. The grievance of the Writ Petitioner is that, the petitioner's name is not mutated with respect to the subject land in an extent of Ac.1.61 cents in total in different survey numbers for the different extents as mentioned in the Form-6A application, dated 25.10.2022 till now by disposing of the same by the 4<sup>th</sup> respondent.
- 3. The learned counsel for the petitioner submits that, the petitioner acquired Ac.14 cents in Sy.No.59-7, Ac.0.16 cents in Sy.No.61-6, Ac.0.17 cents in Sy.No.62-10, Ac.0.19 cents in Sy.No.63-10, Ac.0.23 cents in Sy.No.63-13, Ac.0.04 cents in

Sy.No.64-9, Ac.0.22 cents in Sy.No.64-20, Ac.0.07 cents in Sy.No.65.5, Ac.0.13 cents in Sy.No.68-8, Ac.0.11 cents in Sy.No.68-16, Ac.0.15 cents in Sy.No.68-14 respectively in total an extent of Ac.1.61 cents situated at Damineedu village, Tirupathi Rural Mandal, Tirupathi District through the Gift Deed executed in the year, 1981. Thereafter, though she approached the Revenue Authorities for mutation of her name in the Revenue Records for the subject land, the same has not been considered so far. Hence, she filed Form-6A application dated 25.10.2022 to the 4th respondent mentioning the details of the subject land for mutation of her name in the Revenue Records. But, the same is not acted upon so far.

- 4. On the other hand, the learned Assistant Government Pleader for Revenue, appearing for the respondents, submits that the 4<sup>th</sup> respondent would act upon the application of the petitioner, dated 25.10.2022 by following the due procedure.
- 5. In view of the above said facts and circumstances, the 4<sup>th</sup> respondent is directed to consider and dispose of the Form-6A application of the petitioner, dated 25.10.2022 as expeditiously as possible, strictly in accordance with law, within a period of three (03) months from the date of receipt of this order. After hearing all the parties concerned, including the petitioner and upon verification of the records and the subject land appropriate decision shall be passed as per law.

Accordingly, the Writ Petition is disposed of. No costs.

As a sequel, Miscellaneous Petitions pending, if any, shall stands closed.
