Considering the submissions made by the learned counsel for the petitioners, the Sentence of imprisonment imposed by the Court below alone is suspended pending disposal of the Criminal Revision Case. The petitioners herein shall be enlarged on bail on their executing a personal bond for a sum of Rs.10,000/- (Rupees ten thousand only) each with two sureties for the like sum each to the satisfaction of the learned II Additional Judicial Magistrate of I Class, Machilipatnam, Krishna District."
