As could be seen from the record, though the writ petition was filed in the year 2017, till today respondent Nos.1 and 2 did not choose to file their counter-affidavits, as stipulated in Writ Proceeding Rules. It shows the callous attitude of the respondent Nos.1 and 2.

The learned G.P for Higher Education seeks time to file counter on behalf of the respondent Nos.1 and 2. His request is conceded provided filing of counter as well as appearance of respondent Nos.1 and 2 by the date next adjournment. In failing to file the counter affidavits by the date of next adjournment, the right of respondent Nos.1 and 2 in filing their counter-affidavits would be forfeited.
