WHEREAS the petitioner has presented under Sections 10 to 12 of the Contempt of Courts Act, 1971, the above case through his Advocate Sri K.R.Srinivas, praying the High Court to call for the respondents/contemnors herein and punish them for their intentional, deliberate and willful violation of the orders dated 03.04.2019, passed by the Court in W.P. No. 4612 of 2019.

WHEREAS the said case coming on for hearing, and whereas the High Court, upon perusing the affidavit filed therein and the earlier orders of the High Court dated 12.07.2019 and upon hearing the arguments of Sri K.R.Srinivas, Advocate for petitioner and of the GP for the Services I, for the respondents made the following:

ORDER

(taken up through video conferencing)

Sri K.R.Srinivas, learned counsel, appears on behalf of the petitioner.

Learned Government Pleader for Services I appears on behalf of the respondents.

Non-compliance of the order, dated 03.04.2019, passed in W.P.No.4612 of 2019, is alleged in this case. A perusal of the record shows that on 17.07.2019, respondent No.2 issued memo requesting respondent No.1 to examine the proposal of the petitioner for according promotion in the category of Assistant Director as per the Rules in force and take a decision in the matter because he is the competent authority. Despite lapse of more than one year and three months from the date of issuance of the aforesaid memo by respondent No.2 and lapse of more than one year and six months from the date of the order of this Court i.e., 03.04.2019 passed in W.P.No.4612 of 2019, compliance has not yet been reported by the non-applicants though it was required to be done within four weeks from the date of receipt of a copy of the order, dated 03.04.2019, passed in W.P.No.4612 of 2019.

Considering the aforesaid, by way of last indulgence, we grant three weeks time to the non-applicants to submit compliance report. Otherwise, the non-applicants shall remain personally present before this Court on 19.11.2020.
