

Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the 1st Respondent in reconstituting the Screening Committee vide G.O. Rt. No. 282, Water Resources (Services-1) Department dated 3.6.2020 as illegal, arbitrary, unconstitutional and contrary to G.O.Ms.No.230 GAD (Ser D) Department dt.22-05-1999 and G.O.Ms.No.275 GAD (Ser D) Department dt.21-06-1999 and orders in W.P.No.9215/2020 dated 28.5.2020 and set aside the same and consequently declare that any action taken or any proceedings issued by the Respondents pursuant to the reconstitution of the screening committee is null and void. IA NO: 1 OF 2020

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to stay all further proceedings issued in pursuance of G.O. Rt. No. 282, Water Resources (Services-I) Department dated 3.6.2020 issued by Respondents, pending disposal of WP 9993 of 2020, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and orders of the High Court dated 17-06-2020 & 23-06-2020 and upon hearing the arguments of Smt. A Chaya Devi, Advocate for the Petitioners and Sri Bhimarao, learned Government Pleader for Services – III for Respondents, the Court made the following:

Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the Respondents in issuing proceeding No. RC/ENC(Admn.)/C1/C2/9978699/ 2020/Z-1 to 6 Dt.10-06-2020 and consequential rectified proceeding No. RC/ENC(Admn.)/C1/C2/9978699/ 2020/Z-1 to 6 Dt.11-06-2020 as illegal, arbitrary, unconstitutional and in violation of principles of natural justice and liable to be setaside.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents to grant six weeks time for filing objections in response to the proceedings in Rc. No. RC/ENC(Admn.)/C1/C2/9978699/2020/Z-1 to 6 Dt.10-06-2020 and consequential rectified proceedings No. RC/ENC(Admn.)/C1/C2/9978699/2020/Z-1 to 6 Dt. 11-06-2020 issued by the Respondent No.2, pending disposal of WP 9981 of 2020, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and order of the High Court dated 18-06-2020 made herein and upon hearing the arguments of Sri T D Pani Kumar, Advocate for the Petitioners and GP for Irrigation for the Respondents, the Court made the following.

"Heard learned counsel for the petitioners and learned Senior Counsel Sri M. Suredra Rao who states that an implead application has been filed by him.

Office is directed to verify and put up the same.

No counter affidavits have been filed so far by the Government.

Interim orders have been extended in this case from time to time. The matter needs to be considered after filing of counters by concerned respondents.

Let the same be filed within two (2) weeks.

List the matter after two (2) weeks along with W.P.Nos.9215, 2992, 9188 & 9981 of 2020.

Interim orders granted on the earlier occasion in W.P.No.9993 of 2020 & 9981 of 2020 are extended by four (4) weeks."
