Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction, more particularly one in the nature of Writ of Mandamus declaring the action of the 3rd Respondent in paying compensation at the rate of Rs.12,50,000/- per acre to the petitioner in respect of the lands assigned to him i.e., Ac.4.95 cents in Sy.No. 303/BA of of Kancheru Village, Bhogapuram Mandal, Vizianagaram District, acquired for establishment of International Greenfield Airport, in pursuance of the Preliminary Notification dated 31.08.2015 issued by the 2nd Respondent under Section 11 and the Declaration in Letter No.2314/2015/G3 dated 23.04.2016 issued under section 19(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, for short the Act, in contravention of the provisions of the Act and the compensation fixed in respect of patta lands under G.O.Ms.No.259, Revenue (Assn.I) Department dated 21.06.2016 and G.O.Rt.No.64, Energy, Infrastructure and Investment (Airports) Department, dated 09.06.2016 as arbitrary, illegal, unjust, violation of the constitutional and fundamental rights guaranteed under the Constitution of India, violative of principles of natural justice and contrary to the law laid down by this Hon'ble Court in Land Acquisition Officer - cum - Revenue Divisional Officer, Chevella Division, Hyd. and others versus Mekala Pandu and others, reported in (2004) 2 ALD 451, and also contrary to the judgment of this Hon'ble Court in WP.No.23148 of 2018, and for issuance of a consequential direction to the Respondents to pay compensation in respect of the aforesaid assigned land to the petitioner in terms of the Act or on par with patta lands as determined under the aforesaid G.Os..

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to stay of the petitioner's eviction from the lands admeasuring Ac.4.95 Cents in Sy.No.303/BA of Kancheru Village, Bhogapuram Mandal, Vizianagaram District, till payment of compensation to the Petitioner on par with the patta lands, pending disposal of WP 10232 of 2020, on the file of the High Court.
