Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ, order or orders more particularly one in the nature of writ of mandamus declaring the action of the respondents in trying to dispossess the petitioners from the land to an extent of Ac. 0.03 cents each in Sy No. 1413/2A, situated at Sombeddypalli Village, B.Mattam Mandal, Y.S.R. Kadapa District as illegal, arbitrary, unconstitutional and violation of principles of natural justice and also in violation of Articles 14, 16, 21 and 300A of the Constitution of India and consequently direct the respondents not to dispossess the petitioners from the land to an extent of Ac. 0.03 cents each in Sy No. 1413/2A, situated at Sombeddypalli Village, B.Mattam Mandal, Y.S.R. Kadapa District.
