Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction, more particularly one in the nature of writ of mandamus, directing the respondents 4 and 5 to restore the physical possession of 0.04 cents of land in RS No. 49-3, situated at Kotalaparru Village, Penugonda Mandal, West Godavari District and further direct the respondents 6 and 7 to pay Rs. 24,000/- towards loss sustained by me on account of felling away two fruit bearing coconut trees in my land and also value of two bags of paddy at prevailing market rate till possession is restored to petitioner.

**IA NO: 1 OF 2020 :** Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in W.P., the High Court may be pleased to grant stay of all further proceedings in pursuance to the acquisition of land in R.S.No. 49-3, admeasuring 0.04 cents, situated at Kotalaparru Village, Penugonda Mandal, West Godavari District and not to allot the land for house sites, pending disposal of WP No. 11447 of 2020, on the file of the High Court.


