THE HON'BLE SRI JUSTICE D.RAMESH WRIT PETITION No. 40228 of 2012

ORDER:

The Writ Petition is filed under Article 226 of the Constitution of India seeking to declare the orders in proceedings Rc.No.1998/2010-G, dated 10.01.2010 issued by the 4th respondent and consequential orders in proceedings ACD No.42/2010-S7, dated 17.02.2011 passed by the 3rd respondent and the proceedings in Revision Case No.1 of 2011-S7 dated 04.4.2012 passed by the 2nd respondent and the proceedings in Memo No.1136/CS-1(1)/2012-13 dated 01.12.2012 passed by the 1st respondent confirming the cancellation of the authorization of the petitioner, as illegal, arbitrary and contrary to the provisions of APPDS Control Order 2008 and to pass such other order or orders as the Court may deem fit.

- 2. Heard learned counsel for the petitioner and learned Assistant Government Pleader appearing for respondents.
- 3. Considering the submissions and on perusal of the record, this Court passed interim order on 31.12.2012 granting interim direction as prayed for.

- 4. Subsequently the respondents have filed counter and vacate stay petition and the same was also considered by this Court on 07.6.2013 and the vacate stay petition was dismissed by making the interim order dated 31.12.2012 as absolute.
- 5. In view of the same, the petitioner has been continuing as fair price shop dealer as on today. As contended by the learned counsel for the petitioner that the respondents have passed the impugned orders only basing on the show cause notice and explanation that to without conducting any enquiry as per clause V(v) of Control Orders 2008 correspondent (4)(8) of Control Orders of 2018.
- Considering the submissions of the learned counsel for 6. the petitioner, this Court is of the opinion that the impugned 10.01.2010, 17.02.2011, dated 04.4.2012 01.12.2012 of the respondent nos.4 to 1 respectively are contrary to the directions of this Court. Hence, the impugned orders dated 10.01.2010, 17.02.2011, 04.4.2012 01.12.2012 of the respondent nos.4 to 1 respectively are set aside and the respondents are directed to continue the petitioner as Fair Price Shop Dealer of Gogulamudi Village, Pedanandipadu Mandal, Guntur District. However, liberty is

the respondents to conduct enquiry and take appropriate action in the matter.

7. Accordingly, the writ petition is disposed of. No costs.

As a sequel miscellaneous applications, pending, if any, shall also stand closed.
