Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to declaring the action of the Respondents in not transferring the petitioner from Valasapalli anganwadi center to kolimi veedhi anganwadi center, 4th and 5 ward, kamalapuram village where the anganwadi worker post is vacant and not considering the representation of the petitioner dated 21-05-2018 for the same is illegal arbitrary and violation of the Article 14 a nd 21 of the Constitution of India and consequently direct the Respondents to transfer the petitioner from Valasapalli anganwadi center to kolimi veedhi anganwadi center, kamalapuram village where the anganwadi worker post is vacant.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to consider the representation of the petitioner dated 21-05-2018 for tansferring the petitioner from Valasapalli anganwadi center to kolimi veedhi anganwadi center, 4<sup>th</sup> and 5 ward, kamalapuram village where the anganwadi worker post is vacant, pending disposal of WP 21869 of 2018, on the file of the High Court.

The petitions coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri Sridhar Tummalapudi, Advocate for the Petitioner in WP.No.13376 of 2020 and Sri Suresh Kumar Potturi in W.P.No.21869 of 2020 and GP for Women Development & Child Welfare for the Respondent No.1 to 5 in both the petitions and the Court made the following. **ORDER** 

"The learned Government Pleader for Women Development and Child Welfare submits that the representation of the petitioner for being posted in the Kolimiveedi Anaganwadi Center, Kamalapuram, YSR Kadapa District, was rejected on the ground that there is an order of this Court in W.P.NO.16470 of 2018, filed by one Smt.Krishnavenamma, seeking to be given the post to her.

It is not clear as to how the said post can be filled up by some other person, it is the subject matter of W.P.No.13366 of 2020 when there is such a direction by this Court.

To ascertain the facts, learned Government Pleader is given time till 18.08.2020.

Post these writ petitions along with W.P.No.16470 of 2018.

In the meanwhile, the respondents shall not declare any results on the basis of the interview process that is being taken up and no appointments shall be made for a period of two (2) weeks."
