Writ of Mandamus to declare the action of the 1st respondent in issuing G.O.Ms.No.7 Energy (Power-III) Department dated 08.04.2022 exorbitantly increasing the levy of electricity duty from Re.0.06 per unit of Re.1.00 per unit, against writ petitioner in colorable exercise of the powers conferred under Sec.3(1) of the Andhra Pradesh Electricity Duty Act, 1939 is as arbitrary, unreasonable excessive, violative of Art 14 & 21 of the Constitution of India, contrary to the National Tariff Policy, 2016 and consequently set aside G.O.Ms.No.7 energy (Power-III) Department Dt.08.04.2022 in so far as writ petitioner.

Given the facts and circumstances of the case, the petitioner shall continue to pay the electricity duty collected @ Rs.0.06 paise per unit (KWH), to the licensees, along with arrears, if any.
