The learned Advocate General for the State and the learned counsel for the respondent had finished arguments in the case relating to similarly placed employees corporations etc., In this case also the writ petitioner retired on 30.06.2022 and the impugned order was passed on 12.04.2023. For the very same reasons that were mentioned earlier namely that granting of the interim order virtually grants final order is not approved by the Supreme Court of India and as the entire issue has been argued threadbare in connected appeals and are reserved for orders. There shall be suspension of the order as prayed for.
