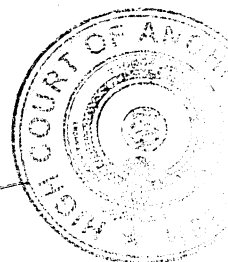

**The Court made the following:**

**ORDER:**

"This Revision Case is filed against the common order dated 27.05.2020 passed in F.C.O.P.No.117 of 2018 whereby the Court below has directed the petitioner/husband herein to pay an amount of Rs.15,000/- per month to the petitioner therein from the date of filing of the petition.

Learned counsel for the petitioner submits that the arrears of maintenance comes to Rs.4,05,000/-.

The operation of the common order dated 27.05.2020 passed in F.C.O.P.No.117 of 2018 on the file of the Judge XIV Additional District and Sessions Judge – Cum – Judge, Addl. Family Court, Vijayawada, is suspended until further orders on the condition of the petitioner depositing an amount of Rs.4,05,000/- towards arrears of maintenance within a period of eight weeks from today and thereafter he shall continue to pay monthly maintenance of Rs.7,500/- to respondent No.2 herein.

**Notice before admission, returnable in two (2) weeks.**

Learned Additional Public Prosecutor takes notice on behalf of respondent No.1.

Learned counsel for the petitioner is permitted to take out personal notice on respondent No.2 by any recognized mode of service and shall file proof of the same.
