Rights in Land and Pattadar Passbooks Act, 1971 and the Rules thereon besides being violative of articles 14, 21 and 300(A) of the constitution of India and consequently direct the respondents not to disturb the peaceful possession of the petitioner in the subject property and not to change or implement any name/corrections in the revenue records for plots bearing number 342, 343, 344, 346 to 352 and 407 to 411 situated in Sy.No. 242/2 (old Sy.No.242) of Tiruchanur Village, Tirupati (Rural) Mandal, Tirupati District belonging to the petitioner;

Learned Assistant Government Pleader for Revenue seeks time to get instructions.

List the matter immediately after Summer Vacation-2024.

In the meantime, in the facts and circumstances, the respondent Nos.3 to 5 shall not change or make sub-division in respect of the petitioner's plots, referred to supra in Sy.No.242/2 of Tiruchanur Village, Tirupati (Rural) Mandal, Tirupati District, without following due process of law."
