WHEREAS the Petitioners above named through their Advocate Sri Avinash Desai presented this Petition under Section 482 of Cr.P.C, praying that in the circumstances stated in the memorandum of grounds filed in the Criminal Petition, the High Court may be pleased to call for the records in CC No. 202 of 2019 pending on the file of Judicial Magistrate of First Class Mydukur for the offenses under Suction 138 read with Section 142 of Negotiable Instruments Act, 1881 and consequently quash the complaint filed by the Respondent No. 2 in CC No. 202 of 2019 pending on the file of Judicial Magistrate of First Class Mydukur thereby set aside the cognizance order dated 12-04-2019 as the same is illegal, arbitrary, without jurisdiction and abuse of process of law.

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri Avinash Desai, Advocate for the Petitioner and of Public Prosecutor for Respondent No.1, directed issue of notice to the Respondent herein to show cause as to why this CRIMINAL PETITION should not be admitted.

Act, 1881 is a holder of the cheque and is not entitled to file any complaint against the petitioner under the Act, 1881.

Considering the submissions made and on perusal of the material on record, there shall be stay of all further proceedings in C.C.No.202 of 2019 on the file of the Judicial Magistrate of First Class, Mydukur for a period of eight (08) weeks.
