Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction, more particularly, one in the nature of WRIT OF MANDAMUS declaring the inaction of the Respondents authorities intaking steps to stop the illegal constructions of the 9th Respondent in Gram Panchayat land in R.S.No. 384 to an extent of Ac.0-05 cents situated at Nagayyapeta Village, Devarapalli Mandal, Anakapalli District and removing the illegal structures therein as illegal and constitutional and consequently direct the respondent authorities to remove the structures of any kind in the Gram Panchayat land in R.S.No. 384 to an extent of Ac.0-05 cents situated at Nagayyapeta Village, Devarapalli Mandal, Anakapalli District while initiating proceedings against the authorities concerned who failed to take any action in spite of representations made to them in this regard.
