Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction, more particularly a WRIT OF MANDAMUS directing the Respondents to include the land of the petitioner total admeasuring Ac.3.16 cents in Survey No.1/2 situated at Kondakarla Village, Atchuthapuram Mandal, Visakhapatnam District in the Web Land cite of the Government by updating the same to facilitate the Petitioner to mutate his name in the revenue records.

ORDER:-

This Writ Petition under Article 226 of the Constitution of India is filed seeking to direct the respondents to include the land of the petitioner total admeasuring Ac.3.16 cents in Sy.No.1/2 situated at Kondakarla Village, Atchuthapuram Mandal, Visakhapatnam District in the web land cite of the Government by updating the same to facilitate the petitioner to mutate his name in the revenue records.

2. Heard the learned counsel for the petitioner and the learned Government Pleader appearing for the respondents.

3. During hearing, the learned counsel for the petitioner limited his request to dispose of the Spandana representation dated 14.03.2022.

4. Learned Assistant Government Pleader readily agreed to dispose of the said representation, in accordance with law.

5. Recording the submissions of the learned Counsel for the petitioner and the learned Assistant Government Pleader for Revenue, the respondent authorities are directed

to dispose of the Spandana representation submitted by the petitioner on 14.03.2022, within a period of four(4) weeks from the date of receipt of a copy of this order and communicate the same to the petitioner.

6. With the above direction, this Writ Petition is disposed of. No costs.

Consequently miscellaneous applications pending, if any in the Writ Petition, shall also stand closed.
