Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring G.O.Rt.No. 197 dated 01.08.2019 issued by the 1st respondent thereby appointing Asst. Government Pleaders without considering meritorious candidates and equality of women and contrary to the guidelines in G.O.Ms.No. 187 dated 06.12.2000 as illegal, irregular and violative of Articles 14, 16 and 21 of Constitution of India and consequently suspend G.O.Rt.No. 197 dated 01.08.2019 in so far as appointment of Respondent Nos. 3 to 16 as Asst. Govt. Pleaders is concerned.

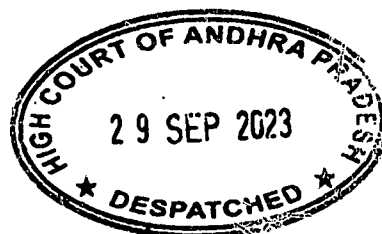
