By the order under appeal, the learned single Judge allowed the prayer made by the writ petitioners and directed the appellant and respondent Nos.64 to 66 herein to reinstate the writ petitioners into service, if they are below the age of 60 years.

Considering the submissions made by the learned counsel for the parties, we deem it appropriate to suspend the order of the learned single Judge.

Accordingly, the order under appeal insofar as it relates to W.P.No.2277 of 2020 is suspended till disposal of the appeal.
