Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction more particularly one in the nature of Writ of Mandamus to declaring the action on the part of the respondents here in not releasing the bills of Execution and completion of works for Improvements of ,-- Kokkirayakunta Village Tank at Atkuru Village in Unguturu Mandal Krishna Dist. worth of Rupees 15,54,099/-with interest as per the agreement No.22 SE/2018-2019 dt 29-6-2018 to the petitioner till today since December 2018 and causing heavy loss with interest even though total works were completed as illegal arbitrary and violative of article 14,16,21 of constitution of India and

consequentially direct the respondents to release and pay the bills worth of Rupees 15,54,099/-with interest to the petitioner fourthwith for completion of works for Improvements of Kokkirayakunta Village Tank at Atkuru Village in Unquturu Mandal Krishna Dist.

# THE HON'BLE SRI JUSTICE VENKATESWARLU NIMMAGADDA WRIT PETITION NO.15092 OF 2021

#### **ORDER:**

Heard learned counsel for the petitioner and learned Government Pleader for the respondents.

When the matter is taken up for hearing, learned Government Pleader submitted that the orders of this Court dated 28.10.2021 has been complied with by paying the total due amount claimed by the petitioner.

On the other hand, learned counsel for the petitioner submits that the respondents paid the principal amount, but not paid the interest as claimed by the petitioner.

In view of the submissions made by the learned counsel for the petitioner and learned Government Pleader that it is an admitted fact that the principal amount was already paid as claimed by the petitioner in terms of the orders of this Hon'ble Court. The contention of the learned Government Pleader that the further claim of interest for delayed payment can be agitated by way of initiation of separate/ fresh legal proceedings is also valid and sustainable.

In view of the facts and circumstances and for the reasons as stated above, the present Writ Petition is closed granting liberty to the petitioner

to claim the interest amount, if any, by way of initiation of fresh/ separate legal proceedings in accordance with law. There shall be no order as to costs.

As a sequel, miscellaneous petitions, if any, pending shall stand closed.
