"In these circumstances, the respondents No. 4 and 6 are directed to implement the orders of this Tribunal in R.P.No.1570/84 and M.A.No.4070/2001 and grant the pay scale of Grade-I Language Pandits to the applicants from the date of their eligibility and pass appropriate orders within a period of four weeks from the date of receipt of a copy of this order."

The contempt application was filed in the year 2019 against the non-implementation of the order passed by the Tribunal and C.A.No.30 of 2019 was renumbered as C.C.(AT).No.513 of 2023.
