

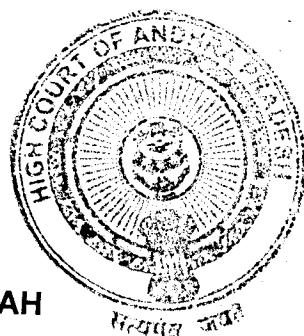

ORDER:

It is submitted that similar issue is pending before the Hon'ble Supreme Court in S.L.P.No.4722 of 2021, in which interim stay has been granted in favour of the Department.

The matter be listed upon disposal of S.L.P.No.4722 of 2021.

In the mean time, interim order granted by this Court dated 04.08.2021 shall continue.
