Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ order or direction more particularly one in the nature of Writ of Certiorari calling for the records connected with order and decree dated 27-06-2019 passed by the A.P. Endowments Tribunal, Pedakakani, Guntur District in O.A 645/2017 in respect of land to the extent of Ac.0-25 cents R.S.No.252/1 of Surampalli Village, Gannavaram Mandal, Krishna District and quash the same as the same is passed without any piece of material for relief of permanent injunction as illegal, arbitrary contrary to law, violative of principles of natural justice.

P.Rajani, Government Pleader Endowments for Respondent No.2 & 3, the Court made the following. **ORDER**

"Sri Madhava Reddy, learned Standing Counsel, takes notice for first respondent-temple and Smt. P.Rajani, learned Government Pleader for Endowments, takes notice for R2 and R3.

It is submitted by the learned counsel for the petitioner, Sri T. Ramakoteswara Rao, that, without there being any material on record and without marking the documents, the A.P. Endowments Tribunal passed the order under challenge. It is the further submission of the learned counsel that the subject land is a Service Inam Land and the Service Inam Land holder does not fall under the definition of 'Encroacher'. It is also the submission of the learned counsel that Rule 14 of the A.P. Endowments Tribunal Rules, 2010 was not adhered to. These issues require consideration.
