**The learned counsel for the petitioner submits that the respondents have not complied with the interim orders of this Hon'ble Court in W.P.M.P.No.21315 of 2011 in W.P.No.17719 of 2011. Hence this Contempt Case.**

**The respondents violated the above said interim order of this Hon'ble Court on 19.04.2023. Hence it is within the limitation.**

**In view of the above said allegations, the registry is directed to issue notices to the respondents returnable in four (4) weeks from today.**
