Criminal Petition No.4099 of 2023

ORDER:

This Criminal Petition, under Section 438 Cr.P.C., has been filed on behalf of the petitioner/A-3, seeking anticipatory bail, in connection with Crime No.59 of 2023 of Gangavaram Police Station, Chittoor District, registered for the offence punishable under Section 307 read with 34 IPC.

2. Brief facts of the case are that on 04.03.2023, at about 11.00 A.M., A1 to A4 keeping previous grudge in mind that the *de-facto* complainant has not agreed to put the person who was nominated by the accused as Group Leader of Sangamitra, hatched a plan to kill the complainant and when the *de facto* complainant was present in front of Vinayakaswamy Temple at Kellapalli Village, A2 to A4 caught hold the complainant and A1 stabbed the *de-facto* complainant with flick knife on his chest and neck and caused bleeding injuries.

3. Heard. Perused the material on record.

4. The learned counsel for the petitioner submits that according to the contents of FIR, specific act has been attributed as against A1 only. The accusation against the petitioner herein is that he along with A2 and A4 assisted A1 in stabbing the *de facto* complainant resulted the *de facto* complainant received grievous injuries. He further submits that this Court granted anticipatory bail to A.4 vide order dated 26.06.2023 in CrI.P.No.3744 of 2023 and that A.1 & A.2 was also released on bail by the Court below and requested this court to enlarge the petitioner on anticipatory bail.

5. Learned Special Assistant Public Prosecutor submits that major portion of the investigation has been completed.

6. In view of the aforesaid facts and circumstances of the case, since major portion of the investigation has been completed and A1 and other accused were already released on bail, this Court is inclined to grant anticipatory bail to petitioner herein/A3 on the following conditions.

7. In the event of arrest of petitioner herein/A3 in the aforesaid crime, he shall be enlarged on bail on executing a personal bond for a sum of Rs.25,000/- (Rupees Twenty Five Thousand only) with two sureties of the like sum each to the satisfaction of the concerned Arresting Officer. Petitioner herein shall cooperate with the investigation and he shall make himself available for interrogation by a police officer as and when required, and he shall not, directly or indirectly, make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the Court or to any police officer.

The petitioner shall appear before the Station House Officer, concerned, once in a week i.e., on every Friday between 10.00 A.M., and 01.00 P.M., till filing of charge sheet.

8. Accordingly, the Criminal Petition is allowed.
