Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or direction more particularly one in the nature of Writ of Mandamus declaring the proceedings in R.Dis.F1/317957/2020, dated 21- 07-2021 issued by the respondent No.2 in rejecting to delete the land belong to the petitioner in an extant of Ac.2.82 Cents in Sy.No.269/5 of Thottambedu Village and Mandal, Chittoor District, assigned under political sufferers quota to the assignee from the prohibitory lands list stating that the same was not sold prior to 10 years of assignment and the consequential action of the respondent No.4 in refusing to receive and register a Sale Deed for the same as arbitrary, illegal, colorable exercise of power, contrary to the G.O.Ms.No.1743, dated 28-08-1959 and well established legal position apart from being violative of the fundamental and Constitution Rights guaranteed to the petitioner under Articles 14, 19, 21 and 300-A of the Constitution of India and consequently set aside the same by directing the respondents No.2 to delete the land in an extent of Ac.2.82 Cents in Sy.No.269/5 of Thottambedu Village and Mandal, Chittoor District from prohibitory lands list issued by him under section 22-A of registration Act, 1908
