In all these Civil Revision Petitions, the awards of the arbitrator passed under the provisions of the National Highway Act, 1956, were sought to be challenged before the Principal District Judge, Chittoor. The said arbitration petitions, filed under Section 34(3) of Arbitration and Conciliation Act, 1996, were rejected by the Learned Principal District Judge, Chittoor on the ground of delay.

- 2. In all these cases, awards were challenged after the initial period of 30 days and the condonable delay of 30 days had expired.
- 3. Aggrieved by the said orders of rejection/dismissal by the Learned Principal District Judge, Chittoor, the petitioners moved these Civil Revision Petitions contending that the Learned Principal District Judge, Chittoor had the power to condone the delay beyond the extended period of 30 days.

   batch and the same had been negatived by this Court by an Order dated
   23.09.2024.
- Accordingly, these Civil Revision Petitions also stands dismissed.
   There shall be no order as to costs.
