Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to issue Interim Direction directing the respondent to forthwith pay the monthly salary to the petitioner from the month of July 2020 till this date duly suspending the orders passed by the District Collector, in proceedings A1/130/2019 dt.25.6.2020, pending disposal of WP No. 20966 of 2020, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order (The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER:

Sri P.V.Ramana, learned counsel for the petitioner contends that the 2nd respondent-District Collector effected the transfer of the petitioner by the proceedings Ref.A1/130/2019 dated..07.2020, to the post, which was held by Village Revenue Officer, Grade-II, though the petitioner is Village Revenue Officer, Grade-I. Learned counsel for the petitioner brings further to the notice of this Court that there is a specific ban imposed by the Government for effecting these transfers and in spite of it, the 2nd respondent-District Collector has undertaken this exercise. The complaint of the learned counsel for the petitioner is that in spite of the petitioner joining in his new station and is working hard during Covid times, when his pay bill was presented initially, for the month of July, 2020, the Treasury Authorities did not accept the same on the ground that there is ban imposed by the Government for effecting transfers. Learned counsel further contends that when this difficulty is brought to the notice of the 2nd respondent-District Collector by the petitioner, there was no response. Thus, it is contended that the petitioner is made to work right from July, 2020, without salary and it is causing any amount of hardship. Thus, learned counsel contends that a direction be issued to the 2nd respondent-District Collector to get the salaries paid to the petitioner.

Learned Assistant Government Pleader representing Learned Government Pleader for Services-I opposed.

Nonetheless, the plight of the petitioner has to be considered, which he had never invited. But for proceedings of the 2nd respondent-District Collector, this contingency would not have arisen.

In the circumstances, the 2nd respondent-District Collector is directed to get the salaries paid to the petitioner from July, 2020 till October, 2020, on or before 30.11.2020. He is further directed to get the salaries of the petitioner paid for ensuing months right from November, 2020 onwards.
