



Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to order stay of recovery of an amount of Rs. 9,64,43,156 towards Entry Tax for the period 2016-17, pursuant to ADC Order No. ZH370721OD21370, dated 29.07.2021 passed by the Respondent No.1 and recovery notice dated 25.08.2021 issued by Respondent No.2, pending disposal of WP No. 18923 of 2021, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order.(The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER:

Having regard to the fact that the issue involved in the instant case is identical to the one in W.P.Nos.221738 and 23603 of 2020, there shall be interim stay as prayed for, subject to the condition that the petitioner deposits 25% of the disputed tax, within a period of four weeks from today, in default, the interim stay granted shall stand vacated. If any amount is already deposited, the same shall be given credit to.

List the matter along with W.P.Nos.221738 and 23603 of 2020.
