Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ order or direction more particularly one in the nature of Writ of Mandamus seeking to declare the action of the respondents in interfering with my rights and possession and attempting to lay a road through the land in an extent of Ac.1.21 cents in Sy.No.125 and Ac.1.87 cents situated in Sy.No.40/2A of Thripuravaram Village Fields, KhajipetaMandal, Y.S.R District is arbitrary, illegal, highhanded, colorable exercise of power, well established legal principles apart from being violative of the fundamental and constitutional rights guaranteed to me under Articles 14, 19 and 21 of the Constitution of India and consequently direct the respondents not to interfere with my rights and possession Ac.1.87 cents situated in Sy.No.40/2A of Thripuravaram Village Fields, KhajipetaMandal, Y.S.R District and attempting to lay a road through the land in an extent of Ac.1.21 cents in Sy.No.125 and Ac.1.87 cents situated in Sy.No.40/2A of Thripuravaram Village Fields, KhajipetaMandal, Y.S.R District.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents not to interfere with my rights and possession Ac.1.87 cents situated in Sy.No.40/2A of Thripuravaram Village Fields, KhajipetaMandal, Y.S.R District and lay a road through the land in an extent of Ac.1.21 cents in Sy.No.125 and Ac.1.87 cents situated in Sy.No.40/2A of Thripuravaram Village Fields, KhajipetaMandal, Y.S.R District, pending disposal of WP 16695 of 2023, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Smt. KOTHARU VIJAYESWARI Advocate for the Petitioner and of GP FOR REVENUE for the Respondents 1 to 4 and the Court made the following

ORDER:

"Heard learned counsel for the petitioner. Learned Assistant Government Pleader for Revenue seeks further time to secure instructions.

Considering the submissions made and perusing the latest adangals in respect of the subject matter property, there shall be a direction to the respondents 1 to 4 not to take any action including laying of the road through the subject matter land, until further orders.

List the matter after four weeks.

In the meanwhile, learned counsel for the petitioner is permitted to take out personal notice on respondent No.5 by registered post with acknowledgement due and file proof of service in the Registry."
