WHEREAS the Petitioner above named through her Advocate Sri S Satyanarayana Rao presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly one in the nature of Writ of MANDAMUS.- (a) By declaring the entire action of the respondents, particularly the entire action of the 1<sup>st</sup> respondent in issuing the present impugned procdgs Rc.No.A1/107/2022-10, dated 30.06.2022 wherein unilaterally at the instance/pressure of the unofficial respondent cancelling the earlier transfer and posting orders issued in favour of the petitioner vide Rc.No.A1/107/2022-10 dated 30.06.2022 of the 1<sup>st</sup> respondent, wherein transferred the petitioner to Govt., BC Girls Hostel, Madanapalle, as per her option and transferring/posting the unofficial respondent at Govt., B.C.Girls Hostel, Madanapalle, vide consequential impugned procdgs Rc.No.A1/107/2022-11, dated 30.06.2022 of the 1st respondent is as highly illegal, arbitrary, unjust, improper, violation of all Principles of natural justice and set aside or quash the same. (b) further hold that the earlier transfer and posting orders issued by the 1st respondent vide procdgs Rc.No.A1/107/2022-10, dated 30.06.2022 wherein transferring and posting the petitioner to Govt., B.C.Girls Hostel, Madanapalle, basing on the recommendations of the committee constituted is holds good for all the purposes (c) and consequently to direct the respondents to reconsider the entire issue in the matter of transfer and posting of the petitioner to Govt., B.C.Girls Hostel, Madanapalle, without reference to the present impugned orders issued in Rc.No.A1/107/2022-10, dated 30.06.2022 wherein transferring the services of the petitioner to Govt., B.C.Girls Hostel, Voyalpadu and consequential impugned procdgs Rc.No.A1/107/2022-11, dated 30.06.2022 of the 1<sup>st</sup> respondent wherein transferring and posting the services of the unofficial respondent to Govt., B.C.Girls Hostel, Madanapalle.
