Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ or order or direction more particularly a writ in the nature of a Writ of Mandamus to declare the action of the Respondents particularly the 3<sup>rd</sup> Respondent in interfering in civil disputes between private parties and trying to disposes the Petitioners from their agricultural lands to an extent of Acres.3.95Cents in Sy.No.19-3 of Kancherupalem Village of Bhogapuram Mandal, Vizianagaram District, to an extent of Acres.1.50 Cents in Sy.No.19-5 of Kancherupalem Village of Bhogapuram Mandal, Vizianagaram District, to an extent of Acres.3.00Cents in Sy.No.19-6 of Kancherupalem Village of Bhogapuram Mandal, Vizianagaram District and to an extent of Acres.1.50 Cents to an in Sy.No.19-5A of Kancherupalem Village of Bhogapuram Mandal, Vizianagaram District, Total. **Writ Petition No.16745 of 2023**

**ORDER:**

The Writ Petition has been filed to declare the action of 3<sup>rd</sup> respondent in interfering with the civil disputes between private parties and trying to disposes the petitioners from their lands, as illegal, arbitrary and consequently direct the 3<sup>rd</sup> respondent not to interfere with the civil disputes between private parties and not to disposes the petitioners from their lands.

2. Learned Assistant Government Pleader for Home, on instructions, submitted that, respondent police are not interfering with the civil disputes between private parties and they never tried to disposes the petitioners from their lands.

3. In view of the above submission of the learned Assistant Government Pleader for Home, recording the same, this Court feels no orders are necessary in the matter.

4. Accordingly, the Writ Petition is disposed of. No costs.

As a sequel, miscellaneous petitions, if any, pending in this Writ Petition shall stand closed.
