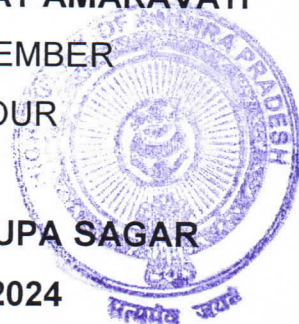

Till then, interim order granted earlier, shall stand extended.

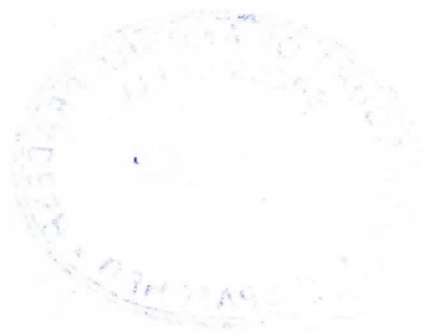
