Petition under Article 226 of the Constitution of India is fled praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ order or direction, more particularly one in the nature of Writ of Mandamus or any other appropriate Writ, declaring G.O.Ms.No. 59 School Education (PS) Department dated 22-06-2023 issued by the 1<sup>st</sup> Respondent and the consequential Memo bearing No.ESE02- 17024/1/2023-PS-1-CSE, Dated 04-07-2023 issued by the 2<sup>nd</sup> Respondent as illegal, arbitrary and in violation of the provisions of the A.P. Right of Children to Free and Compulsory Education Act, 2009 and also in violation of the Rights of petitioner schools guaranteed under the Constitution of India and consequently direct the respondents not to enforce the guidelines framed for rationalization of services of aided staff in private aided schools contained in G.O.Ms.No. 59 School Education (PS) Department, Dated 22-06-2023.
