Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ order or direction, more particular one in the nature of Writ of Mandamus declaring the action of the Respondents herein in dispossessing the Writ Petitioner No.1 from Plot No. 2 in an extent of Ac.0.01 ½ cents in Survey No.82/3 situated at No.84 Ramakuppam Revenue Village of Kuppam Mandal, Chittoor District covered by Possession Declaration Certificate (Anubava Bhruvapatram) vide No.R.Dis A/296/21/8/2007, dated 21.08.2007 and Writ Petitioner No.2 from Plot No. 8 in an extent of Ac.0.01 ½ cents in Survey No.82/3 situated at No.84 Ramakuppam Revenue Village of Kuppam Mandal, Chittoor District covered by Possession Declaration Certificate (Anubava Bhruvapatram) vide No.R.Dis A/296/21/8/2007, dated 21.08.2007 without following the procedure laid down by law as illegal, unconstitutional and arbitrary and consequently restrain the Respondents from dispossessing the Writ Petitioner No.1 from Plot No. 2 in an extent of Ac.0.01 ½ cents in Survey No.82/3 situated at No.84 Ramakuppam Revenue Village of Kuppam Mandal, Chittoor District covered by Possession Declaration Certificate (Anubava Bhruvapatram) vide No.R.Dis A/296/21/8/2007, dated 21.08.2007 and Writ Petitioner No.2 from Plot No. 8 in an extent of Ac.0.01 ½ cents in Survey No.82/3 situated at No.84 Ramakuppam Revenue Village of Kuppam Mandal, Chittoor District covered by Possession Declaration Certificate (Anubava Bhruvapatram) vide No.R.Dis A/296/21/8/2007, dated 21.08.2007.

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to restrain the Respondents from dispossessing the Writ Petitioner No.1 from Plot No. 2 in an extent of Ac.0.01 ½ cents in Survey No.82/3 situated at No.84 Ramakuppam Revenue Village of Kuppam Mandal, Chittoor District covered by Possession Declaration Certificate (Anubava Bhruvapatram) vide No.R.Dis A/296/21/8/2007 dated

21.08.2007 and Writ Petitioner No.2 from Plot No. 8 in an extent of Ac.0.01 1/2 cents in Survey No.82/3 situated at No.84 Ramakuppam Revenue Village of Kuppam Mandal, Chittoor District covered by Possession Declaration Certificate (Anubava Bhruvapatram) vide No.R.Dis A/296/21/8/2007 dated 21.08.2007, pending disposal of the Writ Petition No.20823 of 2022, on the file of the High Court.

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondents not to dispossess from the Petitioners from Plot Nos. 2 and 8 in an extent of Ac.0.01 1/2 cents each in Survey No.82/3 situated at No.84 Ramakuppam Revenue Village of Kuppam Mandal, Chittoor District covered by Possession Declaration Certificate (Anubava Bhruvapatram) vide No.R.Dis A/296/21/8/2007 dated 21.08.2007, pending disposal of the Writ Petition No. 20823 of 2022, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri.V.B.SUBRAHMANYAM Advocate for the Petitioners and learned Government Pleader for Revenue for Respondent Nos 1 to 5, the Court made the following.

ORDER:

Post this case after four (4) weeks.

Meanwhile, the respondents are directed not to dispossess the petitioners from the subject land without following due process of law.
