ii) The respondents are directed to clear the bills

iii) In case, any part payment is made as on date, the

remaining amount shall be paid to the petitioners

forthwith.

iii) The respondents shall pay interest @ 12% per

iv) The interest shall be computed from the date of

expiry of one month from the date of submission of

the bill by the petitioners to till the date of final

payment.

4) There shall be no order as to costs.

Miscellaneous petitions pending, if any, in this case shall

stand closed.
